ARTICLES OF INCORPORATION

OF

THE CHURCH OF SCIENTOLOGY OF LA JOLLA

I

The name of this corporation shall be THE CHURCH OF SCIENTOLOGY OF LA JOLLA.

The purposes for which this corporation is formed are:

- (a) The specific and primary purposes are to act as a Mission for the propogation, worship, and administration of the religious faith, doctrines and practice of Scientology; to regulate and conduct religious services for its congregation; to engage in activities of a religious and educational nature for the local propogation of Scientology; to foster and enhance the spiritual welfare of its followers; to espouse such evidence of the Supreme Being and Human Spirit as may be knowable to Man and by their order, and survival to Man in the external world; and, to propogate and disseminate the Church Creed as set forth in the Bylaws.
  - (b) The general purposes and powers are:
- (1) To solicit, collect, receive, acquire, hold, and invest money and property, both real and personal including money and property received by gift, contribution, bequest, or devise; to sell and convert property, both real and personal, into cash; and to use the funds of this corporation and the proceeds, income, rents, issues, and profits derived from any property of this corporation for any of the purposes for which this corporation is formed.
- (2). To purchase, acquire, own, hold, sell, assign, transfer, dispose of, mortgage, pledge, hypothecate, or encumber, and to deal in shares, bonds, notes, debentures, or other securities or evidences of indebtedness of any person, firm, corporation, or association and, while the owner or holder of them, to exercise all rights, powers, and privileges of ownership;
- (3) To purchase or acquire, own, hold, use lease (either as lessor or lessee), sell, exchange, assign, convey, dispose of, motgage, hypothecate, or encumber real and personal property;
  - (4) To boorow money, incure indebtedness, and to secure

repayment by mortgage, pledge, deed of trust, or other hypothecation of property, both real and personal;

- (5) To enter into, make, perform, and carry out contracts of every kind for any lawful purpose without limit on arount, with any person, firm, association or corporation, municipality, county, parish, state, territory, government (foreign or domestic), or other municipal or governmental subdivision; and
- (6) To do all things necessary, expedient, or appropriate to the accomplishment of any of the objects and purposes for which this corporation is formed.

Notwithstanding any of the above statements of purposes and powers, this corporation shall not engage in activities that in themselves are not in the furtherance of the purposes set forth in subparagraph (a) of this Article II.

This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of California.



The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability to dues and assessments and the method of collection thereof, shall be as set forth in the Bylaws.



The property of this corporation is irrevocably dedicated to charitable, religious or educational purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. No substantial part of the activities of the corporation shall be the carrying on of propoganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office. Upon the winding up or dissolution of the corporation, its assets, remaining after payment, or provision for payment, of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for the charitable, religious or educational purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

If this corporation holds any assets in trust, or the corporation is formed for charitable, religious or educational purposes, such assets shall be disposed of in such manner as may be directed by decree of the superior court of the county in which the corporation has its principal office, upon petition therefore by the Attorney General or by any person concerned in the liquidation, in a proceeding to which the Attorney General is a party.
