



ALLEN KAPULER

Allen Kapuler, director of Scientology and Dianetics in the Washoe area became interested in the subjects professionally fourteen years ago when he was a national chain department store executive and personnel director.

Opening the first Scientology office in Nevada, at Las Vegas in 1964, he and his wife, Virginia, gave private counseling and taught courses to executives and employees of Las Vegas Strip hotels and real estate corporations, developing the largest practice in their field in the world.

In 1968 the Kapulers opened a second office in the state in Washoe County, which quickly grew to be larger than the Las Vegas office, delivering counseling service and courses to individuals who came from as far away as Latin America and Europe.

Mr. Kapuler has recently completed an advance research project and lecture tour on the continent, and upon returning to the states has twice been a guest lecturer at Stanford University on such subjects as psychosomatic illness, emotional problems and marital relations.

The following is an extract from a recent lecture by Mr. Kapuler:

"The subjects of Scientology and Dianetic Counseling have endured and expanded around the world for over nineteen years. It has been developed and refined consistently over the years and is better and more used than ever before.

Journals of the American Medical Association quote statistics that indicate over 70% of man's ills are brought about or persist due to emotional trauma, bringing about psychosomatic ills. Dianetics is simply a precise method of removing the trauma that brought about or holds the psychosomatic ailment in persistence. The rapid end results of this procedure is a well and happy human being who remains that way. The effect of

current or past illnesses, disabilities, perception difficulties, unwanted sensations, fatigue, chronic fears and worries, pain, weight problems, etc. will vanish as the cause is eradicated. The original impact upon the individual is erased leaving the person free thereafter from its effects.

"No, we are not in any conflict with the field of medicine. On the contrary, we advocate medical examinations and treatment as standard policy. If the ailment can be resolved by standard medical means we insist that it be so treated. Our field is not medical healing, and the medical practitioner's field is not psychosomatic predisposition or chronic persistence. There is no intention to usurp medical treatment; we augment physical treatment.

"The techniques used, both in training and in practice, are precise and produce a predictable result. People get better. They are healthy and happy people."

In addition to the office in our area Mr. Kapuler has offices at the South Shore of Lake Tahoe, Sacramento, Santa Clara, San Mateo and Palo Alto.

He is a member of the Sparks Chamber of Commerce and is on its Advisory Council. Besides his activity of directing the expanding counseling offices he is President of Optimum Techniques, Incorporated, building an office building complex on new Rock Boulevard in Sparks, for local attorneys, real estate and insurance companies. Also, he is an executive in a toy firm and a commercial explosive corporation.

He even finds some spare time to give boxing lessons to City Councilman Pete Lemberes' son, Vince. After the last two-hour workout in 90 degree temperature with the six foot teenager he told Pete, "If the boy gets any better I'll either have to stop the lessons or seek the

services of one of my own offices."

Recently Scientology of Sparks and Reno sponsored a classical piano recital at the Pioneer Theatre Auditorium. The guest artist was internationally famous Mario Feninger. The entire proceeds of the concern went to the
